Member agrees that ASCAP shall have the right to verify all data or information regarding any Licensed Premises as may be necessary in order for ASCAP to verify license fees due from Member in any manner and records or other documents of Member which set forth the information needed to compute the license fee. Such information shall be made available to ASCAP by Member or RSA upon ASCAP's request.
